Soil conditions

No trenching in rock or rocky soil conditions

If soil conditions are hard, the hard tariff, as indicated on quotation will be charged per meter

Trench quote for pick able soil

Alpha engineering reserves the right to collect the machine from site if unsatisfied with soil conditions

Standing time

Minimum of R 3500.00 excl vat / day (dry) ditch witch

Minimum of R 2000.00 excl vat / day (dry) k9 mini trencher

(If machine stands due to client)

(If less than amount indicated is trenched, daily tariff will be charged)

Fuel

Exclude diesel (+/- 35-70 litre per day) ditch witch

Exclude diesel (+/- 20-27 litre per day) k9 mini trencher

(Client to supply fuel on site)

Transport (site establishment & de-establishment)

Ditch witch local delivery & collection fee (Bloemfontein) R 3400.00 excl vat

Transport (R 12.00 excl vat / km) ditch witch (site establishment)

Transport (R 12.00 excl vat / km) ditch witch (site de-establishment)

K9 local delivery & collection fee (Bloemfontein) R 1200.00 excl vat

Transport (R 8.00 excl vat / km) k9 digger (site establishment)

Transport (R 8.00 excl vat / km) k9 digger (site de-establishment)

(Except if otherwise indicated on quotation)

Accommodation

Client to supply accommodation 1 x operator(per machine), 1 x foreman

(if necessary for foreman)

Daily transport for operator must be supplied by client

(to site and to accommodation)

Other terms

Client supply 1 worker to assist operator per machine

(to assist with depth measurements)

Raft foundation clients supply 2 x workers to assist operator

All underground services that can be damaged

Is the full responsibility of the client

(e.g. Water pipes, electrical cables, sewage pipes, communication cables)

Health and Safety
